

Physical Description:


Faces north. Two-and-a-half-story, transitional Queen Anne/Colonial Revival, brick-and-stone residence. Regular massing with a tower on the northeast corner. The asphalt-shingle roof is hipped with four projecting gables (one on each elevation), numerous pedimented dormers and one interior brick chimney. The brick walls are embellished with sandstone quoins. The foundation is sandstone. The house is situated on the crest of a short but steep hill. A retaining wall separates the property from the street, and concrete stairs provide access from the sidewalk.

The windows of the house are one-over-one double-hung wood sash. It seems that many of the windows have lost their original upper sash detailing. Some lozenging still survives in the top light of the windows in the attic. Some of the windows are found in pairs. The window frames have segmental arches, with shouldered brick lintels, stone keystones and stone sills. The doors also have segmental arch openings, with shouldered lintels. The door is wood with glass panels, with a transom filling the spandrel area above the door.

The house has two porches. One is located on the first floor, north elevation, with northeast entrance stairs. Four fluted doric columns support the porch roof. A balustrade, solid in the bottom half, spindle in the top half, is suspended between the columns. The other porch is located on the second story north elevation, just east of center, between the gable and the tower. It has the same detailing as the main porch.

This house as a number of architectural details worthy of note; the dentils of the porch, the lozenge pattern in the upper sash of the attic windows, the stone sills, keystones and quoins, and the tower with the pointed octagonal cap.

The house has experienced a number of alterations. The windows may have originally had leaded detailing in the top light. The stove pipes on the west elevation seem to be more recent additions. The stairs to the porch are flanked by newer wrought iron handrails. The roofing material has been changed as has the wall surface of the tower, gable pediments and pents.

Associated structures:

1) This building was originally constructed as a well-house c. 1903 and then doubled in size to accommodate its use as garage c. 1920. The northern half is original while the southern half was added later. It has a flat roof with stepped parapet walls along the perimeter and a stucco exterior. The right half retains its three-leaf wooden sliding track garage door. It is situated directly behind the main house and faces west.

Two other structures (26 1/2 and 30 1/2 Fourth Street) are situated further to the south. They are now functioning residences (See individual building forms) but probably originally served as residences for the men and servants associated with the Gussenhoven family or business.

Historical Information

According to an item appearing in the <u>Plaindealer</u> in 1903, Joseph Gussenhoven had just commenced building his new \$8,000 residence. The house was built with brick manufactured at his neighboring brickyard. Gussenhoven was also building a reservoir with a 1500 gallon capacity to supply water to the brickyard. The siting of the house was probably greatly influenced by the fact that much of Gussenhoven's brick and lumber operations were located just to the west.

This house was built and lived in by Joseph Gussenhoven (1869-1955), a locally important businessman. Gussenhoven, along with his family emigrated to the United States from Holland. Gussenhoven's father had been trained as a civil engineer and was brickmaker in Green Bay, Wisconsin until 1872. At that point he moved to Omaha, Nebraska, where he was newly employed as a surveyor for the Union Pacific Railway. For a period the entire family returned to Holland.

In 1891 Joseph Gussenhoven first came to Havre after a brief stay in Minot, North Dakota where he worked as a bookkeeper. He entered the mercantile trade and gradually developed a myriad of other business interests. In 1893 he lead the movement for open drilled wells. He opened the first steam laundry in Havre in 1897, and by 1902 he was engaged in the brick and lumber business. Gussenhoven was the area's first major contractor and builder. Some of his earlier known buildings include a gymnasium at Fort Assiniboine and the U.S. Weather Building on Second Street in Havre; both built in 1903. Like his own house they were primarily of masonry and supports the fact that he was responsible for the construction of his own home.

In 1910 he discontinued the making of bricks and was principally involved only in lumber. In 1912 he purchased Citizen's National Bank of Havre and served as its president until 1913. In 1914 he became owner and publisher of the Hill County Beacon. Later, he subdivided his property into the area formally called the

- Annexation Plat, but commonly known as the Gussenhoven addition.

Once the eight children that Gussenhoven had raised were grown he moved out of this house in 1929. (See 30 Third St. Inventory Form.) It was used afterwards as a boarding house for single women; many of them young working girls. At one point the woman who ran the boarding house, Irene (last name unknown), called the place "Irene's Castle" (referring, most likely, to the famous actress Irene Castle). It has been nicknamed "The Castle" ever since.

In 1985 the house suffered a tremendous fire. Nothing of the original interior survives today. It stands today vacant and unused.

Integrity:

This building suffered a terrible fire recently and is need of extensive repair and maintenance, for little if anything of the interior survives today. Despite the loss of all interior furnishings and appointments, this structure remains one of the impressive within the community and for much of the state of Montana. The building retains its original Queen Anne massing and configuration and its most signal feature; the corner octagonal tower. It still retains a great deal of its historic fabric, such as the masonry walls and much of its original styling details; in this the porch, window arches and corner quoins.

Significance:

This building is perhaps the most impressive and beloved within the local community. Its generous use of masonry materials (i.e. locally-fired brick and locally-quarried sandstone) is quite rare

for residential buildings in this region. Its transitional Queen Anne/Colonial Revival styling and massing are still visibly distinctive and unique to Havre and this portion of the state of Montana. This building would qualify for the National Register under criteria C and would be a primary contribution to the proposed historic district.

Physical Description:

Small single-story, 2 x 1 bay residence. Faces north. Asphalt-shingled (originally wood shingle up until at least 1939) eavesfront gable roof over rectangular plan with shed-roofed rear extension. Second extension with shed roof on the east side. Interior brick chimney. Clapboard siding of varying gauges.

Concrete foundation.

Right-side primary entry is enclosed with a shed-roofed foyer. Windows vary due to remodelings c. 1970. Most are wood casement type.

The site is level but rises quickly in elevation to the south and west which forms a barrier to the areas beyond in those directions.

Associated structure: Detached single-bay garage located to the rear (S) and to the side (W) of the main structure built sometime between 1920 and 1939. Tar-papered sheathed gable-front gable roof. Open eaves with exposed rafters. Shiplap siding. Garage bay is covered with a pair of swinging single-leaf wooden doors. The structure is unaltered, but is in need of maintenance. This building retains its historic character and would contribute to the proposed historic district.

Historical Information

This house and the one directly to the east (30 1/2 Fourth Street) were originally owned by Joseph Gussenhoven, who lived with his large family at 26 Third Street. It seems that these two smaller residences probably served originally as residences for employees of Mr. Gussenhoven. He owned a large brick-making facility just west of the property and often hired several men on a seasonal basis.

There are no water or sewer records for either of these properties. They are first shown on the 1920 Sanborn Map, but probably pre-date that.

Integrity

This structure has been altered and resheathed but still retains its basic configuration and massing.

Significance

Although greatly altered and remodeled, this is one of only a few

surviving structures that were built before the streets in this area were fully platted and standardized. It would not however, be a contributing element to the proposed historic district. Because of its unusual nature, neither should it be considered an intrusion.



Physical Description:

Single-story, 3 x 4 bay, stuccoed, wood-frame residence. Low hipped-roof with open eaves and exposed rafters over square plan. Two stuccoed interior chimneys. Asphalt shingle roof. Raised concrete foundation.

A pair of entries are located within the center of the main (N) facade. They are both sheltered by an open-air hipped-roof

portico supported by corner wooden porch posts resting on stuccoed sidewalls. They are both approached via a flight of concrete steps.

Windows are 1/1 double-hung with wood sash. Windows are tripled on the main facade.

Site drops in elevation to the north and has a concrete retaining wall along the east of the main structure and before meeting a driveway.

The side (E) facade includes an attached two-bay garage set further from the street than main structure. Faces north with access via a paved driveway that leads to Third Street. Asphalt-shingled hip roof. One garage bay door recently remodeled c. 1970.

Historical Information:

This structure was originally built for Joseph Gussenhoven and his wife. They moved here from their first and much larger home (26 Third Street) when that building was far beyond what they then needed; their children had grown and moved into their own homes. The other half was presumably rented out.

Good. The dwelling still retains much of its original configuration, fabric and detail and therefore its integrity.

The dwelling retains much of its original fabric (stucco exterior walls), detailing (window sashes) and configuration (hipped roof over almost square plan). It would qualify for the National Register under criteria C and would contribute to the proposed historic district.

Physical Description:

Small single-story, 3 x 1 bay, wood-framed residence. Faces north. Asphalt-shingled (originally wood shingle up until at least 1939) eaves-front gable roof. No chimney. Asbestos shingle exterior. Shed-roofed extension that extends beyond the main block of the house to the east. Left-side primary entry now partially boarded over. Windows are full-length 2/2 double-hung

wood sash type with plain wood trim. Secondary entry on north facade of rear extension features wood-paneled door with four upper lights.

Basically level site with steep rises to the south that form a barrier to the areas beyond. Small wire fence surrounds the immediate grounds around the structure.

Historical Information

This building and the one immediately to the west (26 1/2 Fourth Street) were both originally the property of Joseph Gussenhoven and were both probably built by him. Mr. Gussenhoven owned a large brick-making facility just to the west of this property and seasonally hired a great many men to run his operations. It seems quite possible that these houses served as temporary residences for Gussenhoven's temporary employees.

There are no water or sewer records for these two houses. They first appear on the 1920 Samborn Map, but probably pre-date that.

Integrity:

Retains original configuration and original door and window frames. However, new exterior sheathing materials and lack of maintenance have seriously affected this structure.

Significance:

This is one of only a few surviving structures that predate the regular platting of the city's streets and lot boundaries. This accounts for its irregular siting so far from a paved city street. Because of the many alterations and remodelings this building no longer retains its historic character it would not contribute to the proposed historic district. Because of its unusual nature it neither should it be considered an intrusion.





Physical Description:

Oriented to the north, the main block of this simple gable front, one-story house is one bay wide by two bays deep. A full elevation rear addition doubles the depth of the structure. A carport is located on the east elevation. The walls are clad in modern simulated wide clapboard siding. The foundation is cement. The roof is clad in asphalt shingles. The structure is located on a flat lot, with a modest setback.

There are two sets of fixed sash picture windows flanked by

vertical casement windows. Other windows are casement, and oneover-one double-hung wood sash windows. The two main doors are located under the carport, one is solid wood while the other has twelve lights and is covered by a storm door. The carport is supported by metal posts, with a metal screen lattice on the west side of it.

Historical Information

This house is first shown on the 1910 Sanborn Map, the first to cover this area. But a 1906 water hook-up shows this building was at least standing by them.

Paschal Conley was the original owner of this and the other homes that are grouped around the SW corner of Third Street and First Avenue (i.e. 48 Third Street, 52 Third Street, 56 Third Street and 312 First Avenue). The Conley Family lived in a larger home (318 First Avenue) nearby. Paschal Conley probably developed these homes originally as rental units.

In 1929 this house was lived in but not owned by Harry C. Randall (no profession is listed in the 1929 Polk Directory). Other earlier directories do not mention the residents of this structure.





Oriented to the north, the main block of this simple gable-front, one-story house is one bay wide by two bays deep. A full elevation rear addition doubles the depth of the structure. A side entrance section is located on the east elevation. The walls are clad in modern simulated wide clapboard siding with original wood clapboard in the gable pediment. The foundation is

cement. The roof is clad in asphalt shingles. The structure is located on a flat lot, with a modest setback.

There are two sets of fixed sash picture windows flanked by vertical casement windows. Other windows are casement, and one-over-one double-hung wood sash windows. The two main doors are located under the carport, one is solid wood while the other has twelve lights and is covered by a storm door. The entrance area is supported by metal posts, with a metal screen lattice on the west side of it.

Historical Information

This house was one of four that were originally developed and owned by Paschal Conley by 1906. They (48 Third Street, 52 Third Street, 56 Third Street and 312 First Avenue) are all grouped around the SW corner of Third Street and First Avenue and were built at approximately the same time.

It appears that no member of the Conley family lived in any of the residences facing Third Street and that they are originally functioned as rental units. (Paschal Conley is listed as a resident for 312 First Avenue.) They continue to do so today.

Earlier directories (1909-10 and 1915-16) do not make mention of who actually did live in this residence until the one published in 1930. At that point the house was lived in, but not owned, by Tim Chas (no profession for Mr. Chas is listed in the 1929 Polk Directory).





Physical Description:

Single-story, 3 x 2 bay, wood-frame, vernacular Queen Anne cottage, tri-gabled ell residence. Asphalt-shingled gable roof. Aluminum sided. Concrete foundation.

Primary entry contained within ell. Only the concrete floor that runs the width of the ell remains from what was originally an open-air porch. The main (N) facade features two cottage windows; both display colored-glass toplights. The windows of the side (E & W) facades are 1/1 double-hung with wood sash.

The rear (S) facade includes an attached single-bay garage that faces east and is accessed via First Avenue. The garage bay is covered with a pair of single-leaf wooden swinging doors.

The site is level with that of the street.

Historical Information:

This house was one of four (48, 52, 56 Third Street and 312 First Avenue) that are grouped around the SW corner of Third Street and First Avenue and were originally owned and presumably developed by Paschal sometime before 1906. They all probably originally functioned as rentals, as they still do today.

In 1909 this residence was lived in, was it was still owned by Paschal Conley, and lived in by Angus McAuley. Mr. McAuley was a bartender for J.E. Lamey.

In 1929 this house was lived in but not owned by Knute O. and Marie Hafdahl. Mr. Hafdahl was a salesman. Also residing in the house was Raymond Hafdahl, a student.

Integrity:

Good. Despite the addition of aluminum siding this structure retains its original configuration (tri-gabled ell) and important stylistic details closely related with the Queen Anne cottage style (cottage windows with colored-glass multi-paned toplights). The loss of the half-width porch that was originally contiguous with the ell has diminished its integrity, but could possibly be restored.

Significance:

This structure retains much of its original configuration, styling details and therefore most of its architectural integrity

and historic character. This dwelling would qualify for the National Register under criteria C as a vernacular example of the Queen Anne cottage style and would contribute to the proposed historic district.

Frank N. Utter was a Havre lawyer and served as Judge of the District Court for three terms beginning in 1912. He also served as cashier of the Havre National Bank. Utter died of cancer in 1924.

By 1929 this house was lived in, but not owned, by Herbert J. and Esther E. Price. Mr. Price was employed as a "driver" at the time.

By 1933, this house was owned and lived in by Floyd and Bertha Sailor. Two building permits, one dated 1933 and the other 1949, show that the house was substantially altered by the Sailors.

1944. Ray Sands was elected County Commissioner of Hill County.

In 1929 this structure was lived in, but not owned, by Harry J. and Gertrude M. Bell. Mr. Bell was a buyer for the Rainbow Cash Stores Inc. Other residents at that time included Martin A. and Emma O. Bell. Mr. Bell worked as an agricultural assistant at the Montana Agricultural Experiment Station.

was enclosed. Entry is central to facade and is reached by concrete steps flanked by wrought iron railings and decorated wood abutments. Door is original multi-lighted with recent screen addition. Porch windows are Queen Anne-style awning windows.

9/1 double-hung sash windows on walls and rear facade. Multilighted Queen-Anne type casement windows on second floor and on attic windows. Dormer has 9/1 double-hung sash windows.

Attached one-bay garage at rear facing Second Avenue is stylistically similar to house and may have been built about 1920.

Site is level.

Historical Information

The water and sewer records list Alexander D. Smith as the original owner of this house. There is no listing for Smith in the 1909 Polk Directory. By 1909, Smith is still listed as residing in the house. Havre postmaster Thomas McKenzie and immigration agent Samuel Walker are also listed as residents of the building.

By 1915, Samuel Walker was the sole occupant of the house. Walker was now the agent for the U.S. Land Office located in Havre.

In 1929, Arthur and Rae Husser are listed as residents of the house. Husser was a surgeon with offices on First Street. Rae was a nurse at the Havre Clinic on Fourth Avenue. George Husser, a student, is also listed as a resident of the house.



Historical Information:

This house was originally built for Ole Skylsted (1870-1935) sometime around the turn of the century.

Skylsted was born in Bergen, Norway and at age 16 he came to America. He first worked in the coal mines near Chicago, then lived in a sod hut in North Dakota. He moved to Havre when it was connected by train to the East and opened his first store in a tent.

Skylsted tried his hand at a wide variety of businesses that included, the retailing of furniture, real estate, insurance and banking.

By 1929 this house was owned and lived in by James G. Pederson. Mr. Pederson was the President and Manager of the J.G. Pederson & Co. and of Pioneer Market and Wholesale Meats.

In 1943 the house was converted for use as a funeral parlor.
